1. **E-Payment** of **Rs 23,600/- course/admission fee** is to be made by the Candidate by 10th August 2024 by clicking on the link https://www.onlinesbi.sbi/sbicollect/icollecthome.htm (details to make the payment is shown on last page).

This amount is a part of course fee & for confirmation of admission at the time of counseling.

No admission is offered without the above said payment. Candidates are required to fill the Payment Details in Google form (link given below) on or before 10/08/2024 and only these candidates will be contacted for counseling as per schedule.

2. Candidates shall be allowed for counseling only after verification of payment of application/registration fee of Rs. 500/- and other verifications. **Seats will be allotted strictly as per merit order** and after verification of receipt of above shown admission/counseling fee i.e. Rs 23,600/.

- 3. Online/telephonic counseling shall be conducted by NPTI Corporate Office, Faridabad on 12th and 13th August 2024 (10.00am 6.00pm), **please wait for your turn**. NPTI Officers will contact the candidates on their mobile/telephone contact numbers as filled up by them in their Google form. In case, if there is any change in the contact numbers, please update through email (nptipgdcadmissions@gmail.com) latest by 10th August 2024. Candidates are requested to keep their mobile phones ready to receive the calls made by NPTI.
- 4. Candidates will be called rank wise (maximum three consecutive calls will be made to establish the contact with the candidate failing which admission for next candidate will be offered). Candidates are requested to wait for their turn during the above timings of counseling. In case of any queries, candidate may contact at Phone: 0129-2274917/Mr. Aditya 8218228896 (PGDC Cell).
- 5. Only those candidates who are placed in the common merit list and made the payment of Rs. 23,600/- will be contacted for counselling round.
- 6. Once the seat for a particular PGDC Program is allotted during counseling, it cannot be changed later on at any stage.
- 7. After the counseling, the approved list of seat and Institute allotted to the candidates will be posted on our website in due course. After allocation and confirmation of seats, candidates are requested to contact the respective Institutes regarding complete fee components to be deposited at respective Institute, mode of deposition, commencement of the classes etc.
- 8. The date of reporting at the respective Institute is **20/08/2024**. Please refer our prospectus/corrigendum for further details.
- 9. Documents to be produced in Original and one set of self-attested photocopies at the time of Reporting/Joining the course:
 - a) Qualifying Degree/ Provisional Degree certificate issued by the University
 - b) All semester mark sheets of B.E. /B. Tech. or equivalent issued by the University. In case of final year appearing candidates:
 - a. If final year mark sheet issued by University is not available then internet downloaded copy certified by Principal/HOD of the college is acceptable.
 - b. If result is not declared then candidates are not eligible for counseling round.
 - c) Disability certificate issued by competent authority for Physically Challenged candidates.
 - d) Caste certificate (ST/SC/OBC) and non-creamy layer for OBC candidates.
 - e) EWS certificate for Economically Weaker Section candidates.
 - f) In-case of candidates of OBC non creamy layer, the Valid Certificate must have been issued by the concerned authority.
 - g) 10th / 12th Mark sheets & Certificates.
 - h) Photo ID proof issued by Govt.
 - i) E-payment of Rs. 23,600/- (non-refundable) in favor of **National Power Training Institute** payable at **Faridabad**. This amount is a part of course fee & for confirmation of admission at the time of counseling. **No admission is offered without the above said payment.**
 - j) Two Number of recently taken passport size photos (with name and rank in Merit List on the back side of the photograph).
 - k) Sponsorship letter on organization letter head (Applicable only for sponsored candidates).

- 10. Fee for non-sponsored candidates for 1-year PGDC: Rs.1,18,000/-towards 1st installment of training fees to be paid at the time of reporting/joining the allocated institute and 2nd installment of Rs. 1,29,800/- to be paid by 1st Jan-2025.
- 11. In case a selected candidate is asked to withdraw or withdraws from the program for any reasons after commencement of the course, his/her course fee will not be refunded.
- 12. Seats allotted during the counseling will be tentative and NPTI reserves all the rights to start or stop any PGDC program at any institute and also reserves the rights to make any changes in important dates, curriculum and no. of seats in courses offered.
- 13. Reservation of seats shall be as per the norms of Central Government. Seats falling vacant in a particular category shall be allocated to the other categories subject to the eligibility conditions and reservation norms as prevalent from time to time. In case the seat from Sponsored Category remains vacant the same will be thrown open to Non-sponsored category.

14. Course fee details

1	For Non- sponsored candidates (1 year PGDC)	Rs. 2,30,000/- per participant + GST @18%
2.	For sponsored candidates (1 year PGDC)	Rs. 3,60,000/- per participant + GST @18%

Note: - Special 10% discount is applicable for Female Applicants only and there is no Fee concession to any other category of students.

Other fees to be paid by the candidates:

The above course fee does not include other fees like Lodging/Boarding Charges etc.

However, twin sharing hostel accommodation shall be provided to the candidates at the respective training Institute at reasonable charges. Dining facility in the hostels is available at each institute on payment of charges to the institute.

The other institutional fees like Security deposit, Hostel Rent, Transport Charges, food charges etc. has to be paid extra at respective institutes at the time of joining. Separate circular will be issued by respective institute to the candidates at the time of joining.
