**Subject: Observations made by the Inspection Committee during their visit of National Power Training Institute and directions by the Inspection Board for granting extension/continuation of provisional affiliation for existing course(s) for the session 2023-24.**

### A. Observations of Inspection Committee

It is stated that based on the physical inspection performed by inspection committee on dated 12.04.2023 and documents submitted by the Institute following are the observations/suggestions by the Inspection Committee:-

- Faculty members are undergoing development program organised by Institute themselves, more faculty members shall be encouraged to participate in more development programs organised by other institute/bodies.
- Students are participating in the programs organised by Institute themselves; they may be encouraged to participate in inter college/university program.
- Admission is poor in last academic year 2022-23, Institute need to make more efforts to improve the admissions.
- Publication in Journal needs improvement.
- Institute needs to develop a mechanism of Academic Audit.
