1. Observations of Inspection Committee:-

It is stated that based on the physical inspection performed by inspection committee on dated 1.05.2025 and documents submitted by the Institute following are the observations/suggestions by the Inspection Committee:-

- 1.1. Institute should establish student-led clubs in areas such as entrepreneurship, finance, marketing, human resources, culture and social services to support overall development of students.
- 1.2. Conduct regular syllabus revision workshop with participation from industry experts and academic stakeholders to ensure curriculum relevance.
- 1.3. Institute should take steps to Strengthen Industry Institute collaboration through activities like guest lectures, Industrial visits, collaborative projects, mentorship programs and expert sessions.
- 1.4. Formally register an Alumni Association to promote structures engagement and long-term connection with former students.
- 1.5. Encourage alumni contributions in the form of financial donations, scholarships, endowments and support for infrastructure development.

2. Directions by the Inspection Board :-

- 2.1 The Institute must comply the observations/suggestions mentioned by the. respective Inspection Committee during the Physical Inspection before the commencement of the academic programmes for AY 2025-26. The compliance of the same must be submitted in the O/o Dean Institutions in the due time.
- 2.2 The Institute need to be submitted an affidavit duly signed by the Competent Authority of the Institute that the Institute must comply with the observations/suggestions made by the respective Inspection Committee and the Inspection Board within a week from the issuing date of provisional affiliation letter.
- 2.3 The Institute should make suitable effort to get NAAC/NBA Accreditation.
